## **Introduction**

The collection that I chose to evaluate was a small area of the library science section (Library of Congress Classification Z) at Buley Library at Southern Connecticut State University (SCSU). Since SCSU has an academic department for library science, this section is large - filling a couple of aisles. During the time I worked at Buley Library as a student worker, I had noted that this was a section that very in need to be reviewed and updated. As the size of the section was far too large for the purpose of this project, I narrowed my focus to an area covering academic libraries (Library of Congress Classification Z 675 U5), because that is one of my primary focuses of study.

When evaluating the items in this section, there were several considerations I had to keep in mind. The first is that I was working with a collection that had been built based on SCSU's collection development policy. This meant that I could not arbitrarily decide to remove, keep, or add a book, but should ensure that my decision fit within the policies for selection criteria and the criteria for deacquisition. Fortunately, Buley Library's selection criteria is rather broad stating, "Materials are selected according to the needs of the SCSU academic community, scope and content, subject strength, quality, timeliness, bibliographic accessibility, cost, language and country of origin" ("Collection Development Policy", 2001). The collection development policy also provides guidelines for weeding, which aided in my evaluation. The guidelines look at four criteria: physical condition, duplication, content, and editions to help determine whether the item should remain in the collection.

Of particular note in those guidelines is the one for content which states, “Material the contains information that is obsolete, and is not of historical value, will be considered for deaccession. Materials of signal historical, artistic, or bibliographical interest will be considered for inclusion in special collections” (“Collection Development Policy”, 2001). Many of my choices for removal from the section I evaluated were based on the matter of the timeliness of their content. Since library science is a fast-moving discipline, especially in relation to technology, books that are less than a decade old may already be considered obsolete and should be replaced with ones with updated information.

Finally, I had to take into consideration the fact that SCSU teaches library science on both the undergraduate and graduate levels. Therefore some of the books, even if they contain obsolete or superseded material may still have value to a class or researcher looking for historical information. At the same time, though, my experience at SCSU is that many of the graduate courses are taught online and much of the research happens the same way, focusing on articles from library science databases. Therefore if the content of a book is available online, it would be more preferable to keep that.

### **Criteria**

As I evaluated the section of books I chose to use, I based my condition assessment on a scale from “Very Poor” to “Excellent”, intending that books that fell on the lower end of the scale (“Very Poor” and “Poor”) would be closely considered either for repair, replacement, or de-accession. I was very pleased to find, though, that many of the books in the collection are kept in very good condition. Some of this probably comes from the generally low circulation of these books. Through the fifty books I examined, there was only one that was in poor condition.

Since I did not have access to the ILS to gain circulation statistics about the books, I examined the due date stamps in the books to get a rough idea of circulation activity. This is not an exact measure as it ignores library use, online renewals, and circulation staff neglecting to stamp the book, but it was the information that was available to me.

During my evaluation, I considered three different possible results for a book: Keep, Discard, and move Offsite. Books that I decided to keep are obviously going to remain on the shelf. Discarded books were ones that did not meet the selection criteria and I felt should be removed from the collection. I have notes for many of these to either seek an updated edition or another book that provides similar information since I felt that it was valuable to keep in the collection. Finally, my offsite category waffles between keeping and discarding the book. I use this category for books that I was hesitant to discard, because they still seemed to contain relevant and useful information, but was also unsure about its value in the main stacks.

For replacements and new books for the collection, I am using a combination of Books in Print, Choice Reviews, EBSCO's Book Index with Reviews, and Amazon.com to determine availability and suitability.
